CONSENT & WAIVER FORM

Please Read Carefully

Safety glasses and earplugs required; no alcohol allowed; loaded guns allowed only in appropriate areas.

In exchange for and as a condition of being allowed to participate in North Florida Community College Foundation's Clay Shoot, Participant and Participant's parent/legal guardian, if Participant is a minor child, agree as follows:

1. Participant acknowledges that the NFCC Foundation's Clay Shoot features individual and team competition in sporting clays and side games involving the use of firearms.
2. Participant further acknowledges that NFCC Foundation's Clay Shoot will emphasize safe firearm handling and shooting skills.
3. Participant understands that there are risks and dangers associated with the use of firearms, including bodily injury, death and property damage. Participant agrees to assume all risks and responsibility for bodily injury, death and property damage that participant or participant's property may sustain due to, arising out of or in connection with Participant's own participation or the participation of others in NFCC Foundation's Clay Shoot.
4. Participant further covenants not to sue and agrees to release, waive, and discharge NFCC Foundation, NFCC Foundation's Clay Shoot Event Sponsors and NFCC Foundation's Board of Directors, the landowner, and each of NFCC Foundation's respective directors, officers, employees, agents or volunteers from any and all claims, demands, actions, suits, proceedings, liabilities, damages, losses, judgments and expenses (including reasonable attorney's fees and costs) that Participant may suffer, directly or indirectly, due to, arising out of or in connection with Participant's own participation or conduct in the NFCC Foundation's Clay Shoot or the conduct of other participants in the NFCC Foundation's Clay Shoot.

To the fullest extent allowed by law, Participant agrees to defend, indemnify and NFCC Foundation, NFCC Foundation's Clay Shoot Event Sponsors and NFCC Foundation's Board of Directors, the landowners, and each of NFCC Foundation's respective directors, officers, employees, agents or volunteers, harmless from and against any and all claims, demands, actions, suits, proceedings, liabilities, damages, losses, judgments and expenses (including reasonable attorney's fees and costs) by third parties for any bodily injury, death or property damage due to, arising out of or in connection with Participant's own participation or conduct in the NFCC Foundation's Clay Shoot.

Participant grants to NFCC Foundation's Clay Shoot, Event Sponsors and the Governing Bodies permission to reproduce, publish, distribute, or otherwise use in any reasonable manner Participant's name, photograph, likeness and statements in connection with the promotion of NFCC Foundation's Clay Shoot, in all media, including, without limitation, the Internet, news articles, advertisements or other electronic or print materials.
